Hello! Thank you for your interest in participating in Perkasio's excellent summer youth basketball program! Please read this letter in its entirety. If you have any questions, please contact the Parks and Recreation Department at ParkandRec@PerkasieBorough.org.

We will be completing registration **BY TEAM**. If you are willing to accept an individual player please let me know as soon as possible, there are always families moving/etc.

The registration fee is \$715 per team. Registration will be based on a first come first serve basis. Please register your team as soon as possible to ensure your team is included. ONCE COACH INFORMATION IS PROCESSED AND TEAM IS CREATED THEN:

1. An email will go out to all participants alerting them they must go to www.PerkasieRec.com to register for their team.
2. If they already have an account, they can log in and register. New players must have their parent/guardian create accounts.
3. Once logged on they can register for the appropriate division and select their team.
4. Park and Rec staff will check registration process on a regular basis. All teams have one week to register all their players based upon the list filled out below to ensure shirts are ordered in time.
5. Coaches have access through their online account to see their team roster.

Team registration is due Friday, 5/10
Player registration is due Friday, 5/24

The team minimum is 7 players and maximum is 12. *NO* player is allowed to play for more than one team in any division. Divisions are based on the number of teams entered in the division. Age groups may be combined, if necessary, to fill a division. Each team will receive a minimum of ten shirts. Sizes must be indicated for registered team members or you run the risk of having to get creative for your shirt to fit! *Shirts will not be re-ordered, please make sure to indicate correct sizes! These are standard fit, unisex cotton tanks.*

All team information will be accessible to coaches on-line through PerkasieRec.com once team information is received. Schedules will be posted on our website: www.PerkasieRec.com before the league starts in mid-June. Once the scheduled is posted there will be no changes. Note: the only rescheduled games will be those that are rained out. Coaches will be alerted via email about weather related cancellations.

Again, only completely filled out registration forms, including all player information, coach, and payment, will be accepted. You may drop off completed packets to the utility slot at borough hall located as you exit the parking lot. One check or credit card is preferred for payment. We accept Visa, Mastercard, or Discover. We do need a minimum number of teams to play so please help spread the word! We will keep in contact if anything changes. Thank you for your cooperation. We are looking forward to an excellent season in 2024!

Perkasie Borough Youth Summer Basketball League -GAME RULES

1. Referees will be in charge of all games and administration matters
2. Each team must provide one adult at the table to keep time and/or score
3. Games will consist of 2 halves, 20 minute running clock, except for time outs. The clock stops the last minute of each half.
4. Three one-minute time outs per game. One additional time out per team per overtime.
5. First over-time- three minutes; seconds- "sudden death", except in play-offs
6. Pressing: Half court permitted at all times. For the 9th – 12th grade, full court permitted except when leading by 15 or more points. For the 7th & 8th grade, full court during the final 5 minutes of each half, except when leading by 15 or more points. For the 5th & 6th grade, full court during the final 2 minutes of each half, except when leading by 15 or more points.
7. Foul shots: The first 9 foul per half, except those committed during the act of shooting, will be non-shooting fouls played out of bounds. The 10th foul and thereafter each half result in 2 foul shots. (There are no one-and-one's)
8. Any player forgets his/her team shirt will be allowed to play with another shirt of similar color; but the team will be assessed a technical foul.
9. Girl's divisions and 5th & 6th grade boys division will use the smaller ball (women's size). Boy's 7th through 12th will use the larger ball (men's).
10. When rain threatens, a decision to postpone will be made around 5:00 pm. If games are cancelled, please check the website at www.PerkasieRec.com and touch base with your Coach. Coaches are alerted via email if there is a **weather-related cancellation**. Games cancelled due to rain, MUST BE MADE UP WITHIN A WEEK. Make-ups can be played during the week when the court time is available, on Saturday mornings or Sunday nights. Rain during play will result in postponing unless 30 minutes has been played, in which case the game is official except in play-offs.
11. Game standings will be kept by the referees. Be sure your team number and final scores are accurately indicated on the score sheets.
12. Play-offs will be assigned at the end of the season. The top 8 teams in each division make the play-offs. Some divisions this year will take more than 8 teams to be determined by the league. Tie breakers will be first decided head to head, then a coin flip. No additional games will be played to determine seeding.
